

### **Mobile Telephone Voicemail Interception Litigation ("Phone Hacking") – Note to Editors**

At the Case Management Conference on 25 September 2012, it was announced that there were 155 Claimants that had issued proceedings against NewsGroup Newspapers Limited for phone hacking. At the hearing, Mr Justice Vos extended the deadline to issue proceedings and join the Second Tranche of the litigation until 12 October 2012.

Atkins Thomson are the Lead Solicitors for the Claimants and are required to keep a list of all the claims which have been issued. The list is as follows (Please note that the claims with lines drawn through them have either been settled or stayed):
